**All coaches and chaperones:**

- Must be a continuous resident of the Northwest Territories for at least six months prior to the Arctic Winter Games;
- Must be 25 years or older as of December 31, 2025.
- Must have completed the National Coaching Certification Program (NCCP) Make Ethical Decisions and Safe Sport Training Module by February 1, 2026.
- Criminal Record Check: All Coaches/Cultural Managers/Chaperones 18 years or older are required to submit a satisfactory Vulnerable Sector Check in addition to the RCMP criminal records check or EPIC required under section 10(b) by March 1, 2026. Results of checks completed six (6) months prior to the start of the 2026 Arctic Winter Games are considered valid. The Multisport Games Committee or designate reserves the right to review the results of these checks and deny any Participant on the basis of unsatisfactory results of these checks.
